Worcester Public Schools Mentor/Mentee Program for 2016

- 1- The MA Department of Elementary and Secondary Education require new teachers be assigned a Mentor within the first 2 weeks of hire. The district recommends that principals match Mentors with Mentees as early as possible, at least by the first day of school, thereby facilitating new hires integration into the school's culture, procedures and processes. Principals shall select teachers as mentors who have completed at least 3 years of teaching in the district, hold an Initial or Professional educator license in the Mentor/Mentees discipline, and be knowledgeable in adult learning theory, teacher observation, communication and conferencing, effective instructional skills, the teacher evaluation procedure, and other relevant topics.
- 2- New postings recruiting school-based mentors will take place in the spring of the preceding school year. Preference will be given to Focused Instructional Coaches at each building. Mentors must commit to training if they have not previously completed a district or DESE Mentor training program.

The district believes that the EHI and this Mentoring Induction Program meets the necessary Department of Elementary and Secondary Education mentoring requirements to move to the professional level of licensure
